

This book is an anthology of outstanding texts of world sociological literature. The reader will find here works or parts of works by authors well-known in the field of social sciences, such as: Bauman, Blau, Blumer, Bourdieu, Coleman, Giddens, Goffman, Habermas, Homans, Lévi-Strauss, Merton, Offe, Parsons, Ricoeur, Schutz and Tilly. Next to them, texts by authors less known in Poland but equally paradigmatic to modern social sciences, have been included in this collection by science editors. An overwhelming majority of works published in the collection appear in print in Poland for the first time.

The anthology has been divided in 18 parts; each, preceded by an introduction with a synthetic approach, represents a concrete theoretical orientation in current sociology. Marek Ziolkowski's reflections on the state of sociological theory at the beginning of the 21st century provide an introduction to the work as a whole.

Students of sociology and related sciences are the chief addressees of this book. It can be of substantial benefit to lecturers and students of other humanities, e.g. philosophy, philology and cultural studies. The book will be certainly of interest to anthropologists, historians, literary critics and journalists as well.



Dimensions of Silesian Identity



This book is an account of the studies and considerations on a very important region of Poland that is Upper Silesia. The peculiarity of the region has long attracted interest of sociologists but it became a topical issue after 1989 when in the air of democracy and freedom of speech there emerged a possibility of expressing its identity by regional communities. The book is an attempt of sociological description of the process of revival and subsequently, in the newer conditions, creation of regional identity—Silesian identity. The process has been very complicated and so was the political fate of the people living in this region, both native Silesians and newcomers from different parts of the country. Thus it should be stressed that the process of creation of regional identity in Upper Silesia has not ceased yet, so the authors were fortunate to have studied the phenomena in motion, *in statu nascendi*. The authors' approach to regional identity is broad, including topics like the creation of political representation in the region, relations between the political identity of the region and the policy of the whole country, the role of regional media in creation of regional identity, to the role of women in politics, as a symbol and indicator of the role of women in the regional transformation and—last but not least—economic restructuring, mainly of coal-mining industry. Book ends with a kind of resume of recent developments in the public debate over the future of the region and allows to look, at least approximately, at which direction the process being described of creation of modern regional identity will go in.
