

From the Editor:

The book is based on the research project which was designed to investigate perceptions of social differentiation in today's Poland. The research—made in such different social environments like Western and Ukrainian immigrants in Warsaw and Rzeszów, a traditional local community in Podkarpacie and working class in Rzeszów—shown that the problem of forming notions of Polish social organization turned out to be multi-faceted. The material collected sufficiently ample to generate the collection of contributions by members of the project team presented in this volume. The item considered by all of us to be particularly significant in interpreting social realities is space and especially its corresponding social concepts of territoriality.

Our discussion of the role of space and territoriality in constructing cultural interpretations of social realities may be divided into two main perspectives as reflected in the volume's two parts. First, space is an element of a social conception of the world. This perspective permits studying its various understandings by contemporaries.

Part II addresses the problem of multiple symbolic orders and their superimposition as experienced by territory-bound communities as well as immigrants. Here the concept of social field is suggested as a theoretical tool permitting effective description of the symbolic entanglements resulting from such multiplicity.


